



## Calvin B. Taylor Memorial Scholarship for 2023

Calvin B. Taylor Banking Company of Berlin, Maryland announces their 2023 Calvin B. Taylor Memorial Scholarship aimed at first time college applicants who will attend college in the fall of 2023. Under this program, three (3) \$1000 scholarships will be awarded. One student residing within the Indian River School District of Sussex County, Delaware, one student residing in Worcester County, Maryland and one student residing in Accomack County, Virginia.

### Program Guidelines & Priorities:

- \* Seeking graduating seniors from any local high school who reside in the three areas mentioned above. High School location is not a criterion for this as it is based on the residence of the applicant.
- \* Applicants must plan to attend a two (2)-year College/Community College or four (4)-Year College or university.
- \* Scholarship funds will be paid during the summer of **2023**—**directly to the college**, not the student. The scholarship funds will be issued to the college or university upon receiving a certificate of enrollment for the fall semester, which includes the Student ID number and Financial Aid Office address.
- \* Applicants must have the endorsement of their Guidance Counselor on their application attesting they are qualified for this scholarship program.
- \* This complete application packet and any supplemental information, letters, additional sheets of paper, etc. must be received by Taylor Bank no later than **March 1, 2023**. Late or incomplete applications will not be accepted. We encourage you to keep a copy of your full submission for your records.
